#### 9) REGIONAL BROADBAND DEVELOPMENT

The consultant and project managers will provide an update to the Board on the 2021 CEDS project.

Calvin: Broadband initiative, finished action plan, board approved, budget allocations done, public managed broadband entity, proper structure with ability to implement with service providers. Mendo connection – work regionally after entity in place modeled after Sonoma clean power. Share and apply for infrastructure funds/grants including Napa and Marin in consortium. Jeff Tyrell speed test initiative to ID broadband availability launching 2 processes GeoPartners LLC. Sonoma launched. Mendo next 400—500 participants in past week. Data capture successful. Building successful grant application.

Calvin. SMEDD logistics for applying and manage. Federal website logins to register entity and apply, manage. Streamlining logins, etc. When done can apply for grants.

CEDS: Vacations this week.

Jeff: Mendo behind Sonoma but have BOS engaged so adjust messaging and aesthetics.

John Frech: Q: how much money do we have to support broadband?

Calvin: goal of getting organized. Grants SMEDD is eligible for. Originally a planning but can SMEDD be an implement entity as well > board discussion. SMEDD vehicle to leverage funds going forward. Waiting on federal process 4-5 weeks to set up then can apply for grants.

Kelly: Funds + infrastructure assets. SMEDD can be incubator entity that takes over.

Maryanne – Q: Is there another entity that needs to be in place for joint venture? Are we registering as entity for grants? Is this grants.gov?

Calvin yes. Sonoma EDA has been primary so yes creating a separate identity is needed with it's own TIN, Dunn # as to lessen Sonoma responsibility and create separate legal entity

Maryanne – continue to report on progress

Maryanne – Speed test. Desperately need more robust outreach about what it means to be connected. Should devise communication outreach plan to tell community how they contribute. Educate the community to get more funding. Are there funds for this?

Nicholls: Broadband included in questionnaire to capture data

Kelly: is this a 501c3? Or still in operation as JPA but financially separate legally?

Heinze – JPA is separate

Nicholls – Jeff sent Magellan Report + summary to Board members to understand BOS presentation that received 4-0 approval

Calvin – Action plan needed for \$315,000 Sonoma award specific to a governance structure analysis. If there is a new entity, what would that be, etc. Could be done similar to Sonoma Clean Power JPA with ability to expand regionally.

# 10) DISASTER WORKFORCE AND SITE IDENTIFICATION COMMITTEE UPDATE - DISCUSSION (15 min)

The Disaster Workforce and Site Identification Ad Hoc Committee will discuss opportunities for the District to increase collaboration with Counties and other entities to utilize available funds from the U.S. Department of Labor to support displaced workers from COVID-19 or disasters with temporary employment.



Paul Castro, who is absent, has been leading this discussion. It will be postponed to the next meeting. Maryanne, Robin, Paul have not heard update. Meeting was missed last month. Maryanne will reach out to ask him for update for next month's meeting.

Nicholls: Remind Paul bylaws state that members which have 3 consecutive absences may lose board membership.

  - i. Slow start. EPS struggled with jurisdiction understanding but doing better.
  - ii. Bradley and Marie contribution is vital to this.
  - iii. Survey will help. Better path now.
  - iv. Marie working closely with Ashley to move the ball forward.
- d. Mike: Basecamp documents. Everyone take time to review and use this meeting as platform for questions. His review saw that LatinX community was left out of survey and instead focused on the Asian community. Need to address this to keep survey inclusive of all key demographics in Sonoma County. Please read Basecamp documents and provide feedback and direction to EPS.
- e. Maryanne Poverty level demographic also missing. Demographic is growing. There are poverty "islands" in Sonoma County. All of Mendocino County now considered low income.
- f. Mike: Broadband Questionnaire asking "how you rank in a disaster" should add importance of 2-way radio comms when cell towers, broadband, power, land lines all go down with no access to 911.
- g. Lisa What is role of SMEDD going forward? Is it a convener? For example, there are great opportunities with broadband and SMEDD to act as a clearinghouse for upcoming funding opportunities.

  - i. Sending the Board the Survey Monkey done for 2016 CEDS for reference and to inform current process.
