**MOTION**: Director Garza and seconded by Vice Chair Badenfort to approve a list of programs and projects upon which the remaining grant funds may be expended ("Proposed Work Plan"); and direct the management team submit any forms and/or documents that may be required by the U.S. Economic Development Administration such that the Proposed Work Plan be approved by the U.S. EDA if needed; and to Authorize the negotiation of any contracts which may be required with vendors or service providers, subject to contract execution limits outlined below, and to expend remaining grant funds because of the time constraints; therefore, the Board authorized the SMEDD Board Chair to execute contracts for U.S. Economic Development Administration Supplemental Grant expenditures without further Board approval subject to the following provisions: to Individual contracts which exceed \$25,000 shall be executed only after review and approval by the Board at a regular or special meeting; to Individual contracts up to \$25,000 may be executed by the Board Chair provided that, once the total proposed contracts for any single vendor reach \$25,000, any proposed subsequent contracts be submitted to the Board of Directors for its approval. Motion was approved by a 6 Yes/0 No roll call vote.

**Item 2** Consideration and Approval of \$180,000 Contract Amendment with Regional Government Services to Perform Development Administration Supplemental Grant No. ED20SEA3070045.

#### STATEMENT OF ISSUE:

The purpose of this item is for the Sonoma Mendocino Economic Development District (SMEDD) Board of Directors to consider and discuss the approval of submitting the draft FY 2023-2024 Comprehensive Economic Development Strategy (CEDS) update report to the United States Economic Development Administration.

#### FINANCIAL IMPACTS:

There are no anticipated financial impacts.

#### BACKGROUND:

The SMEDD is responsible for overseeing coordination, monitoring implementation progress, and supporting on-going planning of the Sonoma-Mendocino CEDS and its economic development goals. This core function of the District is intended to occur annually through a comprehensive stakeholder engagement process, whereby progress towards existing Goals are noted, opportunities to support improved implementation are identified, and new Goal-aligned projects are identified.

Each year the Sonoma Mendocino Economic Development District is required to provide an update to the Economic Development Administration (EDA). The purpose of the update is to provide a gauge of progress on projects that are directly related to the four main goals in the CEDS: Develop Innovative and Value-Added Economic Sectors, Increase Equitable Community-Wide Prosperity, Support People, and Plan for & Implement Resilience.

The EDA requires that a CEDS update is comprised of five major components:

- Adjustment to the Strategy;
- Report on Economic Development Activities;
- Evaluation on Action Plan and Goals;

- Schedule of Goals for the next year;
- and Economic Resiliency.

The section that primarily changes year to year is the, "report on economic development activities" section of the update.

#### DISCUSSION:

The draft FY 2023-2024 CEDS Update and Performance Report encapsulates critical component insights gained during FY 2023-2024. Submitting this report to the EDA will satisfy the EDA's requirement for an annual CEDS update. This year's update is more comprehensive than years past given the outreach to economic development project proponents. Through the outreach efforts, The SMEDD management team has connected with a project lead on approximately 50% of the one-hundred-two total CEDS projects. The CEDS update outlines twenty-five projects that show substantial progress and alignment with the four CEDS goals. Additionally, the CEDS update describes in detail project updates and descriptions on six projects that the management team has been directly involved with. #### **STRATEGY COMMITTEE**

Over the course of the next year the Sonoma Mendocino Economic Development District professional team will continue to engage with our Strategy Committee and local stakeholders in the region. From recent events, such as the May 30, 2023, Ag-Tech Innovation Brainstorming workshop, we have received feedback that local stakeholders are interested in the continuation and expansion of Goal One in the CEDS: developing innovative and value-added economic sectors. This call to action did not go unnoticed. In June, 2023, the District submitted a letter of interest to the International Economic Development Council to host an Economic Recovery Corps Fellow to implement CEDS Goals 1 and 2 in mutual fashion. The primary objective of the Fellow will be to "foster equitable economic prosperity through strengthening and developing efforts and partnerships among local tribes, nonprofits, governments, and businesses to embrace business growth, job creation, job training and education, research, and innovation around the blue (ocean related), green (land and agriculture related), and creative/tourism

economies". Additionally, through our outreach, we were able to gain feedback on expanding our goal in developing the green economy to include, "Support innovations in technologies to support a healthy, climate resilient agricultural sector". Moving forward, this expansion will be critical to our considerations for an ag-tech innovation hub and diversifying North Coast agriculture as a whole.

In addition to doubling down on the efforts around the green economy, the SMEDD professional team is engaging in a series of meetings with both the Sonoma County and Mendocino County Supervisors' offices. From these meetings, the team has received feedback on additional projects, strategies, and SWOTs that fall in the purview of the CEDS Goals and should be added to the appendix of the CEDS.

# Report on Economic Development Activities

The Sonoma Mendocino Economic Development District (SMEDD) has conducted hours of outreach, resources, and drafting to update the new CEDS. In doing so, the team has interviewed and convened stakeholders to report on progress of existing projects and development of new opportunities and projects that directly align with the Sonoma Mendocino CEDS. Below are a list of relevant projects, their descriptions, their CEDS relation/impact, and future involvement by the District.

In early January 2024, the SMEDD undertook a review of CEDS projects and prioritizing them according to the following criteria:

- 1. The project organization's staff capacity
- 2. Has a project budget been established, and if so how detailed is it?
- 3. What level of economic impact will the project provide?
- 4. Has the project been started? Does it have momentum?

This exercise has outlined a new method of project tracking that the team can utilize moving forward. As we continue to monitor economic development activity related to the SMEDD CEDS, we anticipate that understanding the momentum and feasibility of each project will be critical.

In addition to the CEDS being updated, the SMEDD professional team has worked directly with and assisted in implementation activities related to the 2022 CEDS. The most notable of these activities include:

- 1. Broadband Implementation
- 2. CA Jobs First Funding Planning and
- 3. Supporting momentum on Blue Economy innovations along the Sonoma and Mendocino Coast
- 4. Exploring biomass hydrogen feasibility along the 101 corridor
- 5. AgTech innovation and implementation
- 6. EDFC Revolving Loan Fund

These activities directly relate to strategies in the 2022 CEDS including, but not limited to, Inclusive Economic Development, Innovation and Entrepreneurship, and Human Capital.

#### **Broadband Implementation**

In the fall of 2022 the Counties of Sonoma and Mendocino, in partnership with Golden State Connect Authority, applied for and received two grants of \$499,554 and \$500,000 from <u>the California Public Utilities Commission's</u> <u>Local Agency Technical Assistance grant program</u>. The funding is planned to provide a refined high-level broadband network design for unincorporated areas with little or no internet service and low-level, construction-ready design for priority areas. The high-level engineering design derived from this work will be leveraged to acquire additional engineering and infrastructure deployment funds. The scope of work for this grant program is anticipated to be completed within 18 months of the grant award (June 2024).

Both Sonoma and Mendocino Counties have collaborated on Local Agency Technical Assistance grants, which have analyzed the broadband landscape and identified priority projects throughout the region. Additionally, in partnerships, all four NBCBC Counties have successfully submitted Federal Funding Account applications, cumulatively totaling \$96,169,593. Additionally, NBCBC is helping to establish regional digital equity planning through a California Emerging Technology Fund Regional Leadership Grant. SMEDD has been active in the process of planning and bridging the digital divide for the most rural and underserved communities.

For milestones anticipated in the next year, the NBNCBC is processing work plan change requests, which anticipate analysis of wireless connectivity and tower costs, as well as documentation service levels of regional multi-dwelling units where digital redlining may exist.

# CA Jobs First

SMEDD staff is actively participating in the planning and collaboration of the California Jobs First Initiative implementation. California Jobs First formerly CERF (Community Economic Resiliency Fund) is a \$600 million state-wide initiative designed to promote sustainable and equitable recovery from the economic distress of COVID-19. Funding is allocated by region. Sonoma and Mendocino counties are designated to different regions, however they share the common goal of bringing forward projects for funding which align with the 2022 CEDS goals. The SMEDD team is utilizing existing planning and convening efforts to advocate for the development of Ag-tech in the region. Additionally, Biomass utilization is another area in which the SMEDD is working to have regional alignment across the state. The SMEDD team is regularly engaged with each region's respective planning councils to provide data, regional economic insights, and proposals.

#### **Climate Smart AgTech Innovation**

Sonoma Mendocino Economic Development District continues to support Ag-Tech innovation and collaboration. Engagement from regional stakeholders has been robust and diverse including participation from wine growers, local vintners, UCANR and county staff.

Stakeholders have come to understand the vision of an AgTech Innovation and how it can support Mendocino and Sonoma economic development. Opportunities and challenges related to these sectors have been identified and strategies laid out for moving forward.

Results of this diverse engagement and robust feedback included observations and recommendations on how to focus efforts in the District's CEDS goals surrounding supporting the Green economy and the Blue economy, economic resiliency, and supporting people. The next step for this development, and momentum on its CEDS involvement, is to bring together cohorts to seek funding and actualize the strategies and goals for ag-tech advancement and production/product creation.

The SMEDD has engaged various organizations on the topic of Ag-Tech. Two of the most prominent being the Sonoma County Winegrowers Association and the VINE by the University of California department of Agriculture and Natural Resources (UCANR). The Sonoma County Winegrowers have integrated themselves as the premier technology incubator for one of the region's largest cash crops, wine grapes. The Sonoma County Winegrowers have successfully engaged in and implemented private public partnerships with Ford, John Deere, and others to incubate sustainable, efficient, resilient, and climate smart agricultural technologies in their member's vineyards. Such technologies include fully electrified vehicles from Ford and Tractors from John Deere. Additional tech includes AI generated smart spraying systems. The VINE is a knowledge based network organization funded by UCANR. They are currently developing a physical ag-tech incubator and pilot center in California's Sacramento Valley. Their expertise and assets span beyond the physical location. Their primary asset is the vast network of

knowledge that implements ag-tech along each node of the supply chain from producing food to putting it on the table.

Using conversations, knowledge, and enthusiasm from Ag-Tech entities, the SMEDD has been working with regional economic development planning and funding organizations under the CA Jobs First opportunity (previously known as the California Economic Resiliency Fund). Unfortunately, the state has separated the district into two separate regions with Sonoma County joining the Bay Area region and Mendocino County Joining the North Coast. This has provided a challenge to planning and advocating for SMEDD CEDS related goals, but has provided an opportunity to identify sectors that fit the needs of a greater region. Ag-Tech is that sector. Sonoma County has been paired with Marin County to identify approximately four projects to propose to the Bay Area Committee for a portion of the \$9,000,000 of regional funding. The SMEDD has developed a proposal for \$300,000 that would fund a feasibility study and subsequent strategic plan to implement an ag-tech hub in the North Bay North Coast region. The feasibility study would outline the existing regional assets, opportunities, threats, and weaknesses to the ag-tech sector. Additionally, it would provide a comprehensive implementation plan (strategic plan) to develop value added and climate smart industries that are directly and indirectly related to ag production through innovative technology. Leveraging the relationships with the VINE and Sonoma County Winegrowers Association, the feasibility study will outline the existing network and gaps for ag-tech development in our region.

#### **Revolving Loan Fund**

The Economic Development and Financing Corporation (EDFC) is a Community Development Financial Institution (CDFI) that offers loans to start-ups and local businesses that are unable to qualify for a conventional loan. Over the course of the past year, there were several applications for loans from the Sonoma Revolving Loan Fund and with loan funding nearly expended, EDFC in partnership with the Sonoma EDB is looking for creative ways to recapitalize the fund to continue offering financing to Sonoma County businesses . At current EDFC is servicing 8 loans with over \$940,000 from the EDA grant of \$1 million, deployed into the local Sonoma County businesses. Geographically funds have reached almost all segments of the County with loans in; Cloverdale, Healdsburg, Windsor, Santa Rosa, Sonoma, Sebastopol and Annapolis. These loans have gone to create or retain 20.5 FTE jobs in the community.

#### **Blue Economy**

Coastal communities and organizations in Sonoma and Mendocino County are interested in pursuing coastal resilience and climate adaptation projects. In collaboration with them, SMEDD facilitated meetings, and spearheaded the grant pre-proposal application to the National Oceanic and Atmospheric Administration's (NOAA) Office for Coastal Management's Climate Resilience Regional Challenge grant program. Unfortunately, NOAA declined to invite the working group's letter of intent and subsequent ability to apply for the award. The effort was not in vain, as the working relationships, planning, and documents will serve the district well for CEDS projects in the future.

The Blue Economy initiatives in Fort Bragg and Coastal Mendocino County stem from community-engaged planning and development activities centered in the City of Fort Bragg and the Noyo Harbor. Resulting from the 2022 City of Fort Bragg - Former Mill Site Economic Diversification Feasibility Study, a number of key strategic plans and activities have occurred in the past year including: implementation of the Blue Economy Symposium and Learning Festival in Spring 2022; a \$1 million grant from the CA Department of Water Resources to the City of Fort Bragg for a Wave-Powered Desalination Demonstration Project; a \$825,000 EDA grant to Noyo Ocean Science Center for its Marine Science and Visitors Center preliminary design and engineering; and the \$3.2 million Noyo Harbor Revitalization CERF-Pilot Grant Award. Sonoma County is also pursuing infrastructure revitalization funds at Bodega Bay, as well as increasing collaboration with UC Davis Marine Laboratory and the coastal tribes on kelp forest, abalone, and sea otter restoration efforts. The SMEDD team is engaged with on-going coordination around the Blue Economy initiatives exploring cross-jurisdictional funding and project opportunities.

#### Biomass Utilization for Renewable Energy & Hydrogen

In May the Sonoma Economic Development District will host a Biomass Symposium that brought together

industry, academia, Tribes, government and community-based organizations to explore the opportunities and challenges of implementing forest biomass utilization projects for fire safety, forest health, renewable energy, and wood products, and supporting the appropriate growth of sustainable, stewardship-based, rural economic development. The objectives of the symposium are to:

- 1. Support stakeholders to understand the vision of biomass uses and how it can support Mendocino and Sonoma economic development
- 2. Discuss opportunities and challenges related to biomass harvesting and utilization and whether it can support local and/or regional Mendocino and Sonoma growth and sustainability
- 3. Bring together different sectors, communities and individuals to learn from one another and share knowledge on how to sustainably and effectively use biomass

The potential to convert forest biomass into hydrogen fuel has increased in recent years due to technological innovation around treatment, processing, and fuel utilization. Simultaneously, interest has grown within the resource management, conservation, and wildland fire management communities about the potential for utilizing biomass hydrogen technologies and market dynamics to positively impact watershed health and fire risk reduction. Consistent with CEDS Goals 1, 2, and 4, the SMEDD Board is supporting pursuit of a feasibility study focused on the potential of catalyzing a biomass hydrogen supply chain along the Highway 101 corridor linking northern California to the Bay Area. The scope of this feasibility study is in development and funding opportunities are being explored.

## Evaluation of Progress on Action Plan and Goals

Below is an econometric driven summary of progress on goals listed in the 2022 CEDS.<sup>1</sup> The population in Sonoma and Mendocino counties was 579,581 per American Community Survey data for 2018-2022. The region has a civilian labor force of 303,331 with a participation rate of 63.3%. Of individuals aged 25 to 64 in Sonoma and Mendocino counties, 33.4% have a bachelor's degree or higher, which compares with 36.7% in the nation. The median household income in Sonoma and Mendocino counties is \$93,420 and the median house value is \$705,059.<sup>2</sup>


## CEDS Goal 1: Develop Innovative and Value-Added Economic Sectors

The largest sector in the Sonoma Mendocino EDD is Health Care and Social Assistance, employing 41,025 workers. The next-largest sectors in the region are Retail Trade (28,564 workers) and Manufacturing (26,234). High location quotients (LQs) indicate sectors in which a region has high concentrations of employment compared to the national average. The sectors with the largest LQs in the region are Agriculture, Forestry, Fishing and Hunting (LQ = 2.97), Arts, Entertainment, and Recreation (1.59), and Construction (1.33).

#### Total Workers for Sonoma Mendocino EDD by Industry



Sectors in the Sonoma Mendocino EDD with the highest average wages per worker are Utilities (\$141,142), Management of Companies and Enterprises (\$123,093), and Finance and Insurance (\$106,373). Regional sectors with the best job growth (or most moderate job losses) over the last 5 years are Construction (+1,677 jobs), Administrative and Support and Waste Management and Remediation Services (+1,452), and Professional, Scientific, and Technical Services (+409).

Over the next 5 years, employment in the Sonoma Mendocino EDD is projected to contract by 3,427 jobs. The fastest growing sector in the region is expected to be Health Care and Social Assistance with a +0.8% year-over-year rate of growth. The strongest forecast by number of jobs over this period is expected for Health Care and Social Assistance (+1,691 jobs), Management of Companies and Enterprises (+44), and Professional, Scientific, and Technical Services (+3).

A cluster is a geographic concentration of interrelated industries or occupations. The industry cluster in the Sonoma Mendocino EDD with the highest relative concentration is Food Mfg. with a location quotient of 4.31. This cluster employs 13,441 workers in the region with an average wage of \$68,611. Employment in the Food Mfg. cluster is projected to expand in the region about 0.3% per year over the next ten years.




Industry Clusters for Sonoma Mendocino EDD as of 2023Q3




## CEDS Goal 2: Increase Equitable Community-Wide Prosperity

As of 2023Q3, total employment for the Sonoma Mendocino EDD was 260,722 (based on a four-quarter moving average). Over the year ending 2023Q3, employment increased 0.7% in the region.





The unemployment rate for the Sonoma Mendocino EDD was 4.7% as of January 2024. The regional unemployment rate was higher than the national rate of 4.1%. One year earlier, in January 2023, the unemployment rate in the Sonoma Mendocino EDD was 3.8%.

The average worker in the Sonoma Mendocino EDD earned annual wages of \$66,504 as of 2023Q3. Average annual wages per worker increased 2.0% in the region over the preceding four quarters. For comparison purposes, annual average wages were \$70,183 in the nation as of 2023Q3.



## **CEDS Goal 3: Support People**

Expected growth rates for occupations vary by the education and training required. While all employment in the Sonoma Mendocino EDD is projected to contract 0.3% over the next ten years, occupations typically requiring a postgraduate degree are expected to grow 0.1% per year, those requiring a bachelor's degree are forecast to contract 0.1% per year, and occupations typically needing a 2-year degree or certificate are expected to grow 0.0% per year.

# Schedule of Goals for the Next Year

The Sonoma Mendocino Economic Development District's primary objectives are to support economic resilience in the region and become more responsive and nimble in the face of an uncertain future. The CEDS is the primary planning tool to accomplish these objectives. While the SMEDD's most recent CEDS was adopted in 2022, it is a *living* document that requires ongoing engagement. Therefore, the SMEDD intends to keep moving CEDS objectives and projects forward with an annual update process that includes extensive stakeholder engagement.

Given that the SMEDD is responsible for overseeing completion, monitoring implementation progress, and supporting on-going planning of the Sonoma-Mendocino CEDS, we have carefully prepared a robust engagement plan for the CEDS development for this upcoming year. This core function of the District is intended to occur annually through a comprehensive stakeholder engagement process, whereby progress towards existing Goals are noted, opportunities to support improved implementation are identified, and new Goal-aligned projects are identified.

The Board approved FY 23-24 CEDS Update Process, which provides a comprehensive framework to conduct community outreach and engagement has provided the SMEDD team with thorough direction. The SMEDD team will continue to implement this process, maintaining contact with stakeholders to assist and provide information on funding opportunities as they become aware. We have developed a webform to facilitate consolidated, consistent, and simple project updates. The team will distribute the form as it reaches out to project proponents with workshop information. In addition, one on one, in person or zoom meetings have been held with project stakeholders. We plan to continue with this process through FY 24-25 and utilize it for our 2025 CEDS update.

## **Economic Resiliency**

The Sonoma Mendocino Economic Development District's 2022 CEDS has detailed economic resiliency strategies outlined in the Goals and Objectives section of the document. Activities that the District has been involved in that complement resiliency include economic diversification through the Biomass Symposium and planning, AgTech innovation program, exploration of economic impact studies around key water infrastructure decisions, developing green energy solutions including hydrogen reuse, continued expansion of key communications/broadband infrastructure, and development of a workforce specialized in fire-safe landscaping and design.

We have convened community members, leaders, and stakeholders from our region, aligned goals and strategies. For FY 24-25 we seek to bring together cohorts from Blue and Green Economies, Ag-tech, and Biomass to apply for funding, and actualize strategy, implementing projects and bringing the product of these regionally aligned organizations and businesses to market, creating a more sustainable economy.

## Ag Tech Innovation

In May, 2023, The Sonoma Mendocino Economic Development District (SMEDD) hosted an Ag-Tech Innovation conference which invited regional stakeholders from Academia, Private Industry, Tribes, Farm Associations, and Government to participate in developing a framework for a feasibility study that would outline the development of an Ag-Tech Innovation Hub in the North-Bay North-Coast Region. The Event was a success, and the SMEDD has been using the framework to develop Ag-Tech partnerships, facilitate conversations, and apply for funding to develop a feasibility study and subsequent strategic plan.

During the reporting period, The SMEDD has engaged various organizations on the topic of Ag-Tech. Two of the most prominent being the Sonoma County Winegrowers Association and the VINE by the University of California department of Agriculture and Natural Resources (UCANR). The Sonoma County Winegrowers have integrated themselves as the premier technology incubator for one of the region's largest cash crops, wine grapes. The Sonoma County Winegrowers have successfully engaged in and implemented private public partnerships with Ford, John Deere, and others to incubate sustainable, efficient, resilient, and climate smart agricultural technologies in their member's vineyards. Such technologies include fully electrified vehicles from Ford and Tractors from John Deere. Additional tech includes AI generated smart spraying systems. The VINE is a knowledge based network organization funded by UCANR. They are currently developing a physical ag-tech incubator and pilot center in California's Sacramento Valley. Their expertise and assets span beyond the physical location. Their primary asset is the vast network of knowledge that implements ag-tech along each node of the supply chain from producing food to putting it on the table.

Using conversations, knowledge, and enthusiasm from Ag-Tech entities, the SMEDD has been working with regional economic development planning and funding organizations under the CA Jobs First opportunity (previously known as the California Economic Resiliency Fund). Unfortunately, the state has separated the district into two separate regions with Sonoma County joining the Bay Area region and Mendocino County Joining the North Coast. This has provided a challenge to planning and advocating for SMEDD CEDS related goals, but has provided an opportunity to identify sectors that fit the needs of a greater region. Ag-Tech is that sector. Sonoma County has been paired with Marin County to identify approximately four projects to propose to the Bay Area Committee for a portion of the \$9,000,000 of regional funding. The SMEDD has developed a proposal for \$300,000 that would fund a feasibility study and subsequent strategic plan to implement an ag-tech hub in the North Bay North Coast region. The feasibility study would outline the existing regional assets, opportunities, threats, and weaknesses to the ag-tech sector. Additionally, it would provide a comprehensive implementation plan (strategic plan) to develop value added and climate smart industries that are directly and indirectly related to ag production through innovative technology. Leveraging the relationships with the VINE and Sonoma County Winegrowers Association, the feasibility study will outline the existing network and gaps for ag-tech development in our region.

## **Broadband Deployment Planning**

Sonoma and Mendocino Counties have taken significant action to close the internet availability gap by directing staff to research options to expand broadband access. These efforts have been focused on

infrastructure development and advancing utilization ("adoption") of existing resources, where barriers to connectivity are related to affordability rather than lack of infrastructure. The Board's actions parallel recent state and federal grant programs that fund and facilitate broadband planning, infrastructure, and adoption.

In the fall of 2022 the County of Sonoma and Mendocino , entered into partnership with <u>Golden State</u> <u>Connect Authority</u>, applied for and each received a ~\$500,000 grant from the California Public Utilities Commission's <u>Local Agency Technical Assistance</u> grant program. The funding is planned to provide a refined *high-level* broadband network design for unincorporated areas with little or no internet service and *low-level*, construction-ready design for priority areas. The engineering process is a two-step process: 1) the *high-level* general design typically maps out the route the fiber network will take, and 2) the *low-level* design typically shows the fiber to the curb, identifies infrastructure assets like pull boxes, and maps a clear outline for development. These funds will support both types of design. The scope of work for this grant program is anticipated to be completed within 18 months of the grant award (June 2024).

In July and August of 2023, Golden State Connect Authority delivered high-level engineering designs for project areas in both Sonoma and Mendocino Counties. Both Counties used the designs and corresponding metrics to select priority project areas to apply for <u>last mile funding</u> through the California Public Utilities Commission's Federal Funding Account award opportunity. In both counties, the project areas are located directly adjacent to the <u>state's planned middle mile network</u>. The County of Mendocino's project area encompasses the coastal region off of state highway one. Sonoma County's selected projects are non-continuous and located in: Jenner, East Santa Rosa, East Cloverdale, and Walsh Landing. Sonoma and Mendocino Counties are working closely together to coordinate plans to expand service to unserved residents.

To further broadband accessibility and advanced adoption, the County of Sonoma has been awarded a \$300,000 grant from the <u>Federal Communications Commission</u> (FCC) <u>Affordable Connectivity Program</u> (ACP). The grant is intended to be used to drive awareness and enrollment in the largest broadband affordability program in the nation's history. Building upon current community partnerships, the FCC has issued grants to support partner organizations nationwide to serve as trusted community messengers about the ACP and to better equip agencies with the funding necessary to pursue innovative outreach strategies to effectively reach historically unserved and underserved communities. During the reporting period, the County engaged private providers to develop outreach partnerships to serve the communities in need. Additionally, outreach has been conducted via radio, social media, email, events, and physical flyers. Since the award, Sonoma County Staff has engaged in a variety of community outreach events and efforts and the County has seen approximately a 5.5% increase in eligible households enrolled, from 10,438 to 14,412. Unfortunately the Affordable Connectivity Program stopped accepting new household applications in February 2024 due to a lack of funding. The two counties will continue to promote digital adoption and access through partnering with local community organizations and private internet service providers to identify funding for digital training and literacy purposes.

During the reporting period Sonoma and Mendocino Counties redeveloped a MOU with Marin and Napa Counties to engage in a regional broadband planning organization known as the North Bay North Coast Broadband Consortium (NBNCBC). The consortium is composed of staff from each county regularly working on planning and implementing broadband infrastructure expansion. The Consortium is guided by an oversight committee of four County Supervisors, one from each County. The Consortium has been awarded \$600,000 of funding from the California Advanced Services Fund (CASF) from the California Public Utilities Commission and \$120,000 from the California Emerging Technology Fund (CETF). The work plan for the CASF funding is under redevelopment as each County has identified a broadband infrastructure implementation model that best serves its needs. Currently the Consortium is working to develop a workplan that would provide a feasibility study for wireless infrastructure to serve the residences that are considered economically difficult to connect to fiber optic infrastructure. Additionally, there is a desire to develop GIS databases that will provide relevant information to local organizations to apply for CASF infrastructure funding. The CETF funding is being utilized to promote digital access and equity in the region. Including developing community partnerships with nonprofits to connect their clients to resources that can help them financially or technically get connected to the internet.

## **Biomass Utilization**

In May the Sonoma Economic Development District will host a Biomass Symposium bringing together industry, academia, Tribes, government and community-based organizations to explore the opportunities and challenges of implementing forest biomass utilization projects for fire safety, forest health, renewable energy, and wood products, and supporting the appropriate growth of sustainable, stewardship-based, rural economic development.The objectives of the symposium are:

- 1. Support stakeholders to understand the vision of biomass uses and how it can support Mendocino and Sonoma economic development
- Discuss opportunities and challenges related to biomass harvesting and utilization and whether it can support local and/or regional Mendocino and Sonoma growth and sustainability
- 3. Bring together different sectors, communities and individuals to learn from one another and share knowledge on how to sustainably and effectively use biomass

The potential to convert forest biomass into hydrogen fuel has increased in recent years due to technological innovation around treatment, processing, and fuel utilization. Simultaneously, interest has grown within the resource management, conservation, and wildland fire management communities about the potential for utilizing biomass hydrogen technologies and market dynamics to positively impact watershed health and fire risk reduction. Consistent with CEDS Goals 1, 2, and 4, the SMEDD Board is supporting pursuit of a feasibility study focused on the potential of catalyzing a biomass hydrogen supply chain along the Highway 101 corridor linking northern California to the Bay Area. The scope of this feasibility study is in development and funding opportunities are being explored.

Additionally, the SMEDD management team has been working closely with project proponents and stakeholders in the biomass utilization space. Partnering and convening with organizations such as the University of California Department of Agriculture and Natural Resources (UCANR) and the California Energy Commission, SMEDD has provided insightful resources for planning regional projects. One project in particular being the project number seven in the district's CEDS. Fernando Mora, lead, is working on behalf of the Kashia tribe in Sonoma County and with a business development team to acquire the Berry's sawmill property in Cazadero, CA. The tribe will be a part owner to the lumber

production. The mill is intended to be retrofitted to run off a biofuel source and further serve a microgrid for West Sonoma County. As of mid-February, the team is closing in on the property acquisition. The SMEDD management team has assisted the project managers by connecting them to resources at UCANR, the California Energy Commission, the Jobs First initiative, and more. Additionally, the project team will be featured on a panel at the upcoming Biomass symposium. Additionally, with the work of the SMEDD management team, Fernando was connected to an opportunity to acquire more feedstock from Cal Fire Forest Management. The logistics of that deal has not been born out.

Beyond direct assistance, the SMEDD has distributed letters of support and provided planning assistance for five projects in this sector, three of which have been awarded for over \$600,000. See the full list of letters below.

## **California Jobs First**

The SMEDD has been heavily engaged with a statewide economic development effort named California Jobs First (formerly known as the California Economic Resiliency Fund - CERF). Unfortunately, the state has separated the district into two separate regions with Sonoma County joining the Bay Area region and Mendocino County Joining the North Coast. This has provided a challenge to planning and advocating for SMEDD CEDS related goals, but has provided an opportunity to identify sectors that fit the needs of a greater region. As mentioned above, the SMEDD team is utilizing existing planning and convening efforts to advocate for the development of Ag-tech in the region. Additionally, Biomass utilization is another area in which the SMEDD is working to have regional alignment across the state. The SMEDD team is regularly engaged with each region's respective planning councils to provide data, regional economic insights, and proposals.

## Letters of Support

One of the most effective ways SMEDD can be used is to provide letters of support to organizations applying for grant funds for a project that directly relates to the goals in the CEDS. In May, the SMEDD Board of Directors approved the district manager to provide such letters of support in instances of time sensitive need. ## SMEDD Education, Awareness, and Capacity

As stated in the first component of the recovery and resiliency work plan, RGS and SMEDD associates have worked to increase stakeholder understanding, interest and engagement in SMEDD. In early April, the SMEDD team conducted in person outreach, interviews, and listening sessions with Mendocino and Sonoma stakeholders. The outreach efforts for this tour began in late March. The information was well received from local stakeholders and department heads.

The second main goal to accomplish this aspect of the work plan is to Strengthen SMEDD information resources to support resiliency and recovery. During the reporting period, RGS has put in a substantial amount of work to continue developing the district's website, <u>SMEDD.org</u>. Having a web platform and presence allows for the district to effectively reference recovery and resiliency resources such as funding opportunities, local events, partner organizations, and resiliency strategies.

The third main goal to accomplish SMEDD education, awareness, and capacity is to develop productive stakeholder relationships. Though the district has this in some capacity with the CEDS strategy committee, RGS and SMEDD staff are continuously developing these relationships to further recovery and resiliency planning in the region. As outlined below, SMEDD has hosted events such as the business friendliness webinar, a regional Ag-Tech innovation event, a Biomass utilization symposium, and facilitated numerous sector focused working groups aimed to increase industry and economic development/resiliency in the region.

## Recovery and Resiliency Technical Assistance

The RGS and SMEDD associates provided recovery and resiliency technical assistance for Mendocino County and Sonoma County cities through an assessment of business friendliness.

1) Providing a business friendliness assessment: The primary objective for the business assessment is to review incentives, programs, communication, processes, fees, timelines, and demonstrated commitment to economic development as a priority, to facilitate existing businesses, business expansion and attraction. On September 28th, SMEDD provided a webinar to City Managers and Economic Development Directors/ Managers outlining the BFC check up assessment tool. The Business Friendly Check-up establishes a baseline of key metrics that city and community leaders can reference to better understand their communities' strengths and weaknesses in this area. ## Economic Development Recovery and Resiliency Funding

As illustrated in task 3 of the approved work plan amendment for the CARES act award, the SMEDD team evaluated and built the SMEDD's capacity to pursue and secure various sources of grant funding and exceeded the deliverable by pursuing two unique funding sources to promote economic recovery and resiliency in the Sonoma Mendocino region.

## NOAA Coastal Resilience Challenge Regional Working Group

The Sonoma Mendocino Economic Development District served as the lead convener and facilitator for regional stakeholders to work together on developing a letter of intent to apply for an award from the National Oceanic and Atmospheric Administration for Coastal resilience projects. Below is a summary of the letter resulting from the working group led by SMEDD.

## **Regional Context:**

The letter describes the challenges faced by coastal communities in Sonoma and Mendocino counties due to climate change, including the erosion of oceanfront lands, damage to kelp and estuarine ecosystems, and the decline of red abalone populations. The decline in these ecosystems has significant economic and cultural implications, and it affects the fisheries, wetlands, and recreational resources in the region.

### **Resilience Vision:**

Given the context, the SMEDD developed project goals and a vision with the working group to address climate impacts posed by warming waters, rising seas, drought, and increased flooding. The vision includes the following key components:

- 1. Protect, restore, regenerate, propagate, and extend kelp forest refugia.
- 2. Build economic resilience and support a just transition to the changing climate.
- 3. Mitigate estuarine flooding through enhanced ecosystem services.
- 4. Adapt critical harbor infrastructure and public access to rising seas.

### **Proposed Activities and Outcomes:**

The letter outlines several activities and outcomes associated with the project, including:

Kashia Band of Pomo Indians Conservation Aquaculture and Ocean Ecosystem Restoration: This involves working with various partners to launch a regional kelp forest ecosystem restoration alliance and Tribally operated abalone production and restoration facility. The activities include conservation aquaculture, urchin management, ocean stressor assessment, and construction of green infrastructure aquaculture facilities.

Estuary Resilience and Flood Risk Mitigation: This component focuses on rehabilitating and supporting climate adaptation for estuaries in Sonoma and Mendocino counties. Activities include minimizing flooding, sustaining the role of floods in delivering sediment to marshes, sustaining estuaries as rearing habitats for juvenile salmonid species, and sustaining the importance of estuaries as bases for recreation and tourism.

North Coast Harbor Economic and Climate Resilience: After restoring the kelp and marine ecosystem, the project aims to strengthen the blue economy through climate-resilient infrastructure and job diversity. This includes upgrading infrastructure at Bodega Bay, such as the ice plant and docks, and replicating native hatchery salmon releases.

Noyo Center for Marine Science: The project supports the construction of the Ocean Science Center Building in Fort Bragg, which will serve as a hub for marine science education and research. The building will include research laboratories, a marine mammal skeleton articulation workshop, and a marine mammal triage center. The Noyo Center for Marine Science engages with the community and aims to address climate change impacts on coastal ecosystems.

SMEDD Program Coordination & Climate Resilience Regional Amplification: SMEDD plays a pivotal role in coordinating and amplifying the regional response to climate threats. This involves convening workshops, compiling progress reports, supporting elected leaders, and developing and maintaining web resources for project teams and the public.

Unfortunately, the letter of intent was not provided an invitation to apply for the award from the National Oceanic and Atmospheric Administration. The SMEDD will use the working relationships formed from this experience to continue working toward developing value added, climate smart, blue economy jobs.

## California Jobs First Ag Tech Innovation Feasibility Study Proposal

Using conversations, knowledge, and partnerships from regional Ag-Tech entities, the SMEDD has been working with regional economic development planning and funding organizations under the CA Jobs First opportunity (previously known as the California Economic Resiliency Fund). Unfortunately, the state has separated the district into two separate regions with Sonoma County joining the Bay Area region and Mendocino County Joining the North Coast. This has provided a challenge to planning and advocating for SMEDD CEDS related goals, but has provided an opportunity to identify sectors that fit the needs of a greater region. Ag-Tech is that sector. Sonoma County has been paired with Marin County to identify approximately four projects to propose to the Bay Area Committee for a portion of the \$9,000,000 of regional funding. The SMEDD has developed a proposal for \$300,000 that would fund a feasibility study and subsequent strategic plan to implement an ag-tech hub in the North Bay North Coast region. The feasibility study will outline the existing regional assets, opportunities, threats, and weaknesses to the ag-tech sector. Additionally, it would provide a comprehensive implementation plan (strategic plan) to develop value added and climate smart industries that are directly and indirectly related to ag production through innovative technology. Leveraging the relationships with the VINE and Sonoma County Winegrowers Association, the feasibility study will outline the existing network and gaps for ag-tech development in our region.

## Grant Compliance and Oversight

RGS and SMEDD associates are working together to ensure reporting and administrative compliance are in order. This work is being conducted on the County, State, Federal levels.

**STATEMENT OF ISSUE:** The purpose of this item is to receive a Biomass Utilization Symposium planning status update and provide further direction to the District Management team.

### SUMMARY OF RECOMMENDED ACTION:

### FINANCIAL IMPACTS:

Coordination of the Biomass Utilization Symposium will draw down County in-kind staff support (Grant No. ED22SEA3020033) and RGS effort under remaining CARES Act Supplemental Grant funds (Grant No. ED20SEA3070045). External sponsorship and event donations will cover event specific costs. As of April 15, 2024, SMEDD has received a total of \$6,000 in sponsorship pledges from RCRC, Sonoma Water and Mendocino Forest Products. As of April 8th, SMEDD has \$1,630 allocated from West Business Development Center, the fiscal sponsor for the event.

### BACKGROUND:

At the December 12, 2023 SMEDD Board of Directors meeting, the District Manager introduced the concept of the SMEDD co-hosting an Biomass Utilization Symposium as an educational opportunity for the region's stakeholders. The SMEDD Board reviewed a preliminary Symposium Agenda, discussed logistics, and budgeting, and designated Chair Bartholow and Member Garza to serve as an Ad Hoc Committee to work with the district management team to continue planning and coordination for the Symposium. Mendocino County Supervisor Glenn McGourty volunteered to join the Symposium planning committee.

### **DISCUSSION:**

Since the February meeting, the management team, Ad Hoc Committee and Mendocino County Supervisor McGourty met several times to prepare and finalize the event agenda, secure speakers, and pre-symposium tour options. As of this meeting the SMEDDBiomass Utilization Symposium plans are in are in place, registration is open and tickets are being sold, and the main effort is focused on filling the target 100 seats (+20 scholarships and 30 speakers) for a total of 150:

## FINANCIAL IMPACTS:

There are no anticipated financial impacts for this item.

### **BACKGROUND:**

During the December 8, 2023 and February 16, 2024 regular SMEDD Board of Directors meetings, the SMEDD Management team provided the Board an overview and update of the CA Jobs First (previously known as CERF) initiative. The overview and update included the following:

- Regional Representation: Sonoma County is represented by the Bay Area Jobs First Collaborative. Mendocino County is represented by the Redwood Region RISE Coalition.
- Both regions have conducted a solicitation for regional projects to be funded by catalyst funds at \$9 million per region
- Each region is guided by the principle to create high wage, climate resilient, and sustainable jobs.

Mendocino County is part of Redwood Region RISE (Resilient Inclusive Sustainable Economy) which is a regional community coalition of close to a thousand members working together to develop a 10-year vision that aims to bring good, sustainable jobs to Tribal Lands, Del Norte, Humboldt, Lake, and Mendocino Counties - through the California Jobs First (previously known as Community Economic Resilience Fund [CERF]) initiative.

The Sonoma County EDB has been working with a subregional round table under the Bay Area Jobs First Collaborative. The subregional roundtable includes Sonoma and Marin Counties. The Subregional roundtable collected projects that meet the fundamental industry and vision priorities. Projects must promote the growth of sustainable, climate forward, high wage, and high growth jobs.



#### DISCUSSION:

#### **Mendocino County - Redwood Region RISE**

The \$9 million in catalyst funds is marked as fully spent within our 4 county region. The allocation of how it will be spent is not yet decided. The CCRP, AEDC and voting table will be responsible for allocating funds. RISE is holding an in-person meeting for voting block members in late April in Humboldt. Voting criteria and scoring will be workshopped by attendees at this meeting. The County of Mendocino Economic Development Division is a member of the voting block for Redwood Region RISE. Economic Development Division staff will participate in the voting selection of projects submitted for development in our region.

There are many Mendocino County engaged actors in the Redwood Region RISE coalition across industry, academia, government and community-based organizations. Within the SMEDD, Board Members, Mendocino County Staff, and the Regional Government Services team are engaged in a variety of intersecting ways. This report summarizes work being led by Mendocino County Staff, Board Member Mary Anne Petrillo, as the Blue Economy & Working Lands Sector Table co-leader, and a new Economic Development Finance Working Group being led by the RGS team.

### Blue Economy Update: 3/21/24

In our pursuit of developing a robust strategy and work plan for the Blue Economy sector, we have made significant strides over the past six weeks. Through a combination of virtual and in-person meetings, our team has grown to over 20 participants, reflecting a diverse array of organizations invested in the region's economic and environmental prosperity.

Achievements:

- 1. Vision Statement: We have crafted a vision statement: *The Redwood Region is poised to* become a global leader in rural regenerative blue economies. To achieve this, we will form collaborative networks of stakeholders to advocate for policy and investment, drive innovative technologies, revitalize infrastructure, create robust and expanded markets, and advance oceanic research.
- 2. **Strategic Directions:** Our strategic directions outline key areas of focus, including advocacy, market expansion, ocean research, and innovation. These directions serve as guiding pillars for our future endeavors.
- 3. **SWOT Analysis:** We have conducted a SWOT analysis, identifying strengths, weaknesses, opportunities, and threats within the Blue Economy sector. This analysis will provide valuable insights for informed decision-making and strategic planning.

While we acknowledge the challenges posed by climate change and sea-level rise, we remain optimistic about the opportunities for development and innovation within the Blue Economy sector. By leveraging



our collective expertise and resources, we are confident in our ability to overcome these challenges because the local Blue Economy presents a multitude of promising opportunities for sustainable growth. Some highlights are streamlined permitting, efficiently managed dredging, advancements in direct sales and harvesting technologies by fishermen, and the proliferation of online platforms for seafood commerce are just a few examples. Additionally, infrastructure improvements and collaborative research initiatives will further enhance the region's potential for both economic and environmental prosperity.

In conclusion, we are progressing in developing our strategy and work plan for the Blue Economy sector in partnership with our working lands contingent because it takes a collective effort to create economic prosperity, environmental sustainability, and community resilience. We are poised to make meaningful contributions to the advancement of a rural regenerative economy in the California Redwood Region.

## Economic Development Finance (EDF) Working Group

Regional Government Services, under a separate service contract with the Arcata Economic Development Corporation (AEDC) serving as the Redwood Region RISE Fiscal Agent, is facilitating the Redwood Region RISE Economic Development Finance (EDF) Working Group. The EDF Working Group is occurring in two phases with Phase 1 happening Jan - June 2024, and Phase 2 following directly through December 2024. - RGS is taking on an expanded role providing Technical Assistance to Sector Table leads in preparing evaluation frameworks for subsequent Catalyst and Implementation funding rounds.

## Sonoma County - Bay Area Jobs First Collaborative

The Sonoma-Marin Regional Roundtable's facilitators will vote on a set of initial project submissions and bring them to the larger Bay Area Collaborative in May. In June, the Bay Area Collaborative will bring a set of projects to the State to be funded as pilot projects in this first phase. The Sonoma EDB submitted a project proposal for \$300,000 to fund an Ag-Tech Innovation Hub Feasibility Study for the North Bay that will leverage the May 2023 SMEDD Ag-Tech Brainstorming Session. The feasibility study would investigate key partnerships, regionally unique focus areas, functions, services, phasing options and location alternatives for a potential North Bay Ag-Tech Innovation Hub. Additionally, the feasibility study will take into consideration the efforts that are already underway in the region, and determine if there are opportunities to expand those, rather than start anew.



The SMEDD management team has engaged various organizations on the topic of Ag-Tech to prime regional engagement in this feasibility study . Two of the most prominent being the Sonoma County Winegrowers Association and the VINE by the University of California department of Agriculture and Natural Resources (UCANR). The Sonoma County Winegrowers have established themselves as the premier technology incubator for one of the region's largest cash crops, wine grapes. They have successfully implemented private public partnerships with Ford, John Deere, and others to incubate sustainable, efficient, resilient, and climate smart agricultural technologies in their member's vineyards. Such technologies include fully electrified trucks from Ford and tractors from John Deere. Additional tech includes AI generated smart spraying systems.

The VINE is a knowledge-based network organization funded by the UCANR. The VINE and UCANR are active across the State with Ag-tech innovation centers serving as nodes of a growing state, national and international knowledge and innovation network. Their primary asset is the vast network of knowledge that implements ag-tech along each node of the supply chain from producing food to putting it on the table. Both the Sonoma County Wine Grower and The VINE will be essential partners in the development of a North Bay / North Coast Feasibility Ag-Tech hub Feasibility Study.

#### **STATEMENT OF ISSUE:**

The purpose of this item is to update the Sonoma Mendocino Economic Development District (SMEDD) Board of Directors on the status of Board recruitment efforts in Mendocino and Sonoma counties, provide an update on County processes, and recommendations to fill three vacant board positions.

#### **FINANCIAL IMPACTS:**

There are no anticipated financial impacts.

### BACKGROUND:

The SMEDD Board has nine seats. Three seats are currently vacant. One vacant seat is to be appointed by the County of Mendocino; one vacant seat is to be appointed by the County of Sonoma; the remaining vacant seat is a singular At-Large seat to be appointed by the Board of Directors of the SMEDD. The purpose of this item is to provide the Board with the opportunity to discuss and take action as may be appropriate to filling the two vacant SMEDD Board seats that must be appointed by the respective County Boards of Supervisors, and/or the vacant at-large seat that must be appointed by the SMEDD Board of Directors.

#### DISCUSSION:

The County of Sonoma has received three applications for the Sonoma County vacant seat. The Sonoma County Economic Development Board has reviewed these applications and has decided to keep the recruitment for this seat open to allow for a larger breadth of potential applicants to be considered. With the assistance from the Business Diversity Program Manager at the Sonoma County Economic Development Board, the Sonoma County Management Analyst is promoting the vacancy to regional stakeholders that have small business enterprise experience. To date, this effort has produced one

potential applicant that the Sonoma County Economic Development Board is considering for appointment, pending an official application.

The County of Mendocino has a newly vacant Board Member position. Jim Mayfield resigned from the SMEDD Board at the beginning of April. The County of Mendocino has received an application to fill the empty seat. The County's Economic Development Division will be reviewing the application in the next week, and make a determination whether to recommend the candidate to the County of Mendocino Board of Supervisors for appointment to the SMEDD Board.

The SMEDD Board should discuss a process and timeline for recruiting and filling the vacant at-large seat, which is the Board's only at-large seat and the only seat appointed directly by the SMEDD Board. The SMEDD has posted the vacancies on the SMEDD web page, and is using other available opportunities to publicize all the vacancies and invite interested individuals to apply. If the SMEDD Board would like to recruit with an application process, an application form could be based upon the existing forms used by the Counties. The At-Large vacancy could be publicized either with an application deadline or as "open-until-filled". The Board may wish to personally recruit candidates.
