#### STATEMENT OF ISSUE:

The purpose of this item is to update the Sonoma Mendocino Economic Development District (SMEDD) Board of Directors on the status of Board recruitment efforts in Mendocino and Sonoma counties, provide an update on County processes, respective County reviews, and recommendations for prospective applicants to fill the vacant board positions.

#### **FINANCIAL IMPACTS:**

There are no anticipated financial impacts.

#### **BACKGROUND:**

Currently there are three vacant Board seats on the Board of the SMEDD. One Board seat is to be appointed by the Mendocino Board of Supervisors, one board seat is to be appointed by the Sonoma County Board of Supervisors, and the third vacant board seat is to be appointed by the SMEDD Board of Directors. Sonoma County has received two applications. The Sonoma County Economic Development Board has reviewed these applications and is prepared to bring a recommendation to the Sonoma County Board of Supervisors on the November 7, 2023, County of Sonoma Board Meeting Agenda. The description of the candidates and the Sonoma County Economic Development Board's recommendation are below.

#### **DISCUSSION:**

The Sonoma County Economic Development Board (EDB) has reviewed two applications for the vacant Sonoma County SMEDD board seat. The first application is from a person who is a member of the City of Cloverdale City Council and is currently serving as Mayor of the City of Cloverdale. The second application is from a person who resides in western Sonoma County and is a member of the Lower Russian River Municipal Advisory Council; they have extensive experience in project management and working in the technology industry. After review, it is the Sonoma County EDB's recommendation to the

Sonoma County Board of Supervisors to appoint the latter of the aforementioned candidates to the SMEDD Board.

Mendocino County has received four applications for the vacant Mendocino SMEDD Board seat. Initially, the Mendocino County Economic Development Standing Committee planned to interview the candidates and recommend a candidate to the Mendocino Board of Supervisors; however, the Board voted to dissolve the Standing Committee at its September 12, 2023, meeting. Mendocino staff is working with the Clerk of the Board to establish the next steps.

#### **STATEMENT OF ISSUE:**

The purpose of this item is to consider approval of SMEDD being the applicant for the completion of a sewer infrastructure project in West Santa Rosa.

#### **SUMMARY OF RECOMMENDED ACTION:**

Approve staff to explore and agree to a grant administration partnership with the City of Santa Rosa for this funding award in the financial and strategic interest of SMEDD.

#### **FINANCIAL IMPACTS:**

Authorizing this action would increase the need for financial reporting and management. However, those costs will be offset by the award itself, if awarded.

#### **BACKGROUND:**

In May of 2021, Malinda Matson, Economic Development Representative from the Economic Development Administration, was given a project tour by representatives of the City of Santa Rosa and in company of the Interim District Manager of SMEDD. One of the project sites visited on the tour was a large commercial lot in Western Santa Rosa adjacent to Dutton Avenue. The parcels adjacent to this stretch of Dutton Avenue are zoned for commercial use and residential use, but currently lack adequate sewer infrastructure. The construction and installation of this infrastructure will allow for increased economic development capacity for the adjacent parcels. The EDA indicated that SMEDD could serve as an administrative and/or fiscal agent if the City of Santa Rosa lacks the staff capacity to do so. A conversation with the City of Santa Rosa is still underway as to if there is a need/want for SMEDD to engage in this type of partnership with the City.

#### **DISCUSSION:**

One of the two facilities on the commercial lot was recently acquired by Sonoma County Meat Company, a Sonoma grown woman owned family business that provides meat processing services for regional ranchers and grocery retailers and wholesalers, including those both in Sonoma and Mendocino

Counties. The other facility on the commercial lot was recently vacated by YRC Freight. The residentially zoned lot is currently vacant. The Sewer infrastructure would allow for the expansion of Santa Rosa Meat Company, expanded commercial capacity for the vacant building and be critical infrastructure to the residentially zoned parcel. From preliminary discussions with the City of Santa Rosa, there is an interest in having SMEDD be the applicant for an award to fund this project. The project is supported by all four goals of the 2022 CEDS.

- 1) Developing Value Added Economic Sectors
- 2) Increase Equitable Community Wide Prosperity (Project will increase economic development in EDA designated opportunity Zone)
- 3) Supporting people through the support of entrepreneurs and small business owners
- 4) Increasing resiliency by developing critical water infrastructure.

The award opportunity that will likely be pursued is the <u>EDA's 2023 Public Works and Economic</u> <u>Adjustment Assistance funding opportunity.</u> The City of Santa Rosa would be the lead applicant, with SMEDD serving a role in administering the grant. Construction estimates from 2022 estimated the 600 ft of sewer construction would cost approximately \$600,000. Staff anticipates that the cost of construction is likely higher now due to inflation. If directed by the board to pursue funding in coordination with the City of Santa Rosa, updated estimates will be acquired prior to applying for funding.

#### **BACKGROUND:**

The SMEDD provided a Letter of Support on behalf of RFS proposal to the NCRP Woody Feedstock Aggregation Pilot Project call for proposals on August 9, 2023. The scope of work under the RFS proposal addressed the SMEDD Comprehensive Economic Development Strategy (CEDS) Goal 1: Develop Innovative and Value-Added Economic Sectors, and Goal 4: Plan for & Implement Resilience. The SMEDD was notified that the RFS proposal was selected for a \$60k award on September 15, 2023. Background on the scope of work under this award from the Office of Planning and Research is provided in Attachment A.

#### **DISCUSSION:**

RFS has identified three (3) additional grant funding opportunities with CalFIRE, the Bay Area Council, and US Department of Agriculture, Forest Service, Region 5, that will augment funding received for the

# Sonoma County Woody Feedstock Pilot Project Overview

#### **Pilot Overview**

Regenerative Forest Solutions (RFS), was recently selected to participate in a region-wide cohort under North Coast Resource Partnership's Forest Biomass Strategy, funded under the Office of Planning and Research. In partnership with the Watershed Research and Training Center, RFS will leverage local, regional and state expertise to investigate the opportunities for inter-governmental, cross-sector cooperation to manage fiber flow within the North Bay. In Sonoma's parcelized landscape, bundling contracts will reduce risk for new business creation, provide a reliable market to enable additional fuel reduction projects around the wildland urban interface, and generate place-based, highly-skilled jobs (see page 2).

From October 2023 through December 2024, RFS will lead Working Group members and stakeholders to create a feasibility study and business plan to guide the pilot to implementation. The goals of the study and plan are as follows:

- Feedstock Supply Quantitative and Qualitative Analysis
- Potential Feedstock Demand and Wood Product Market Development
- Establishment of a Draft Ecological Baseline
- Entity Type Recommendation & Governance Structure
- Infrastructure Assessment & Recommendations
- Preliminary Community Outreach, Impact & Engagement Plan
- Financial Modeling

RFS is committed to facilitating and managing the aggregation entity business planning and feasibility planning phase to support a more rapid and ecologically minded restoration regime across the county's ~514,000 acres of forested land. The plan and study will move Sonoma County forward in its ability to create more wildfire and climate resilient landscapes across its forested acreage in collaboration with key agencies and stakeholders. The project team is led by RFS staff members Temra Costa and Jeremy Fisher, and will engage Working Group Members and advisory committee in achieving deliverables.

#### **Woody Feedstock Aggregation Pilot Program**

May 24, 2022

#### **Program Overview**

OPR was provided \$3 million from the <u>Wildfire and Forest Resilience Early Action Package</u>. \$2.5 million to support new long-term wood feedstock pilot projects, \$350,000 through an interagency agreement to spur innovation in the wood sector, and \$150,000 to administer the development of the pilot projects.

As stated in the Wildfire and Forest Resilience Action Plan Objective 3.10, OPR will fund five pilot projects to develop regional strategies to establish reliable access to woody feedstock through a variety of feedstock aggregation mechanisms and organizational innovations. The pilots will develop plans to improve feedstock supply chain logistics within each target region through an institutional arrangement with the structure, authority, and resources to aggregate and initiate long-term feedstock contracts. Each project will explore and assess market opportunities of potential woody biomass businesses in their region and commit to increasing feedstock aggregation on all relevant land types, including private and non-commercial land, especially where opportunity exists to produce community fire resilience benefits. The pilots are distributed across single and multi-county regions in the Central Sierra, the Lake Tahoe Basin, the Shasta and Lassen region, the North Coast and Marin County.

#### **Project Deliverables**

Project deliverables include but are not limited to: (1) organizational studies to investigate potential governance structure(s), fire defensible space enforcement capacity, financial sustainability of entity operations, feedstock availability, wood product businesses and market opportunities, and a community analysis of each project region; (2) a feedstock mapping and aggregation tool; (3) a legal structure implementation plan; (4) an entity action plan; (5) community engagement workshops; (6) templates for long-term feedstock contracts; and (7) wood product campus feasibility study.

#### **Timeline**

Project proposals were submitted on November 1, 2021. Grant agreements completed on January 31, 2022 and are currently under review with DGS. Grant terms are set to run through March 31, 2025. Funds are available for expenditure or encumbrance until June 30, 2022, and for liquidation until June 30, 2025. In addition to the deliverables stated above, each pilot will participate in bi-monthly learning cohort discussion sessions, submit quarterly progress reports, and complete a final report at the end of the grant term. All resources produced during the grant term, from each pilot and the learning cohort, will be made available on the OPR website.
